The tenderer should have sufficient experience in doing similar nature of jobs preferably in Govt. Sector. The tenderer should submit photocopies of his license and papers in support of his work experience. Photo copy of PAN Card is also to be submitted.

The tenderer will be required to deposit 2% of the quoted rate as Earnest Money in the form of Demand Draft in favour of the Trustees of Victoria Memorial, payable at Kolkata. The above earnest money will be refunded after one month from the date of issuance of Work Order.

The successful tenderer will be required to deposit 10% of the total work value as Security Deposit in the same form in which the Earnest money has been deposited to the Trustees of Victoria Memorial before receiving of Work Order. The security money should remain valid for a period of Sixty days beyond the date of completion of guarantee period. The earnest money will be forfeited if the Security Money is not deposited within seven days from the date of intimation in this regard or if the successful tenderer is unable to execute the job within specified time.

The job executed by the successful tenderer shall be guaranteed against bad workmanship for a period of six (6) months from the date of completion of the job. If any defect during the period as mentioned above is detected, he will be liable to rectify the same free of cost within reasonable time.

The job to be executed is scheduled to be inspected by the concerned unit of the VMH.

The job to be executed will follow the Govt. specification.
