The tender in sealed cover should be superscribed with "Tender for disposal of broken branches & uprooted trees" and should be sent to the Administrative Officer, Victoria Memorial Hall within 2.00 p.m on .28/11/18....

The tenders will be opened on the same day at 4.00 p.m. in the office chamber of the Administrative Officer. Tenderers/their representatives may remain present at the time of opening of tender, if they so desire.

The tender should be accompanied by an earnest money deposit of Rs.2000.00 (Rupees two thousand only) in the form of a Bank draft drawn in the favour of "Victoria Memorial Hall" payable at Kolkata. Please note that tender without the earnest money will be rejected outright. Reserved price is Rs.20,000.00 (Rupees Twenty thousand) only.

The rates excluding GST if applicable, should be quoted both in words and figures. The successful tenderer will be required to remove the branches and trees within 7 days of the receipt of work order at their own cost from "as is where is basis".

The intending tenderers are requested to visit the site and make on the spot inspection of the types and quality of trees/branches VMH desires to dispose off. The successful tenderer will be required to deposit the quoted amount within 3 days of the acceptance of the tender failing which the tender will be rejected.
