The tender in sealed cover should be superscribed with 'Tender for construction of 50 nos. new Garden Benches' must be sent to the Administrative Officer, Victoria Memorial Hall within 02 p.m. on16.01.2019. The tenders will be opened on the same day at 3.00 p.m. in the office chamber of Administrative Officer. Tenderers/their representatives may remain present at the time of opening of tender if they so desire.

The rate should be inclusive of all charges i.e. supply of materials, fitting, fixing and taxes, if any, including transportation etc. The rates should be quoted both in words and figures. The successful bidder will be required to complete the job within 30 days of the receipt of the order. The work should be done with cast iron, paver tiles etc. under the supervision of the Carpenter and the Caretaker.
