Victoria Memorial Hall, 1 –Queen's Way, Kolkata – 700071 (2223 0953) invites sealed tenders for disposal of unserviceable/ broken electrical goods/ accessories on "As is where is Basis" subject to following term conditions. The goods/ accessories may be inspected between 2:30 PM and 4:00 PM on any working day. The tender in sealed cover should be superscripted with "Tender for purchase of unserviceable/ damaged/ broken electrical materials etc" and should be sent to the Secretary & Curator, Victoria Memorial Hall, before 12:00 Noon on or before 19<sup>th</sup> January 2021

The tenders will be opened on the same day at 1:00 PM in the chamber of the Accounts Officer. Tenderer/ their representatives may remain present at the time of opening of tender, if they so desire.

The tender should will be accompanied by an Earnest Money deposit of Rs. 2600/- (Rupee Thirteen Thousand) only in the form of a Bank draft in the favour of "Trustees of Victoria Memorial" at Kolkata. Please note that tender without the EMD will be rejected outright. Reserved price is Rs. 1,30,000/- (Rupee One Lakh Thirty Thousand) only.

The rate should be quoted both in words and figures and be exclusive of all taxes, duties & charges, if any, which, if those be any are to be paid by purchaser from his / their own resources and VMH will not be responsible in any way. The successful bidder will have to deposit the bid amount in full by cash/ DD in favour of "Trustees of Victoria Memorial" payable at Kolkata within 02 working days on receipt of the letter of award. The unserviceable/ broken/ damaged material etc will have to be removed from the VM campus by the successful bidder at their own cost within 02 days. Any delay in taking delivery of materials beyond the specified period may attract ground rent as per general terms or may lead to termination of contract. The Earnest Money shall be forfeited if the successful bidder withdraws from the offer or does not deposit the bid amount within stipulated period. In case of unsuccessful tenderer/s, the EMD will be refunded at the earliest and latest on or before the 30<sup>th</sup> day after the award.

The unserviceable/ damaged/ broken materials etc will be sold on "As is Where is Basis" and Victoria Memorial Hall shall not be responsible for their usefulness or quality.
