The goods/ accessories may be inspected between 2:30 PM and 4:00 PM on any working day. The tender as per enclosed Proforma and in sealed cover should be superscripted with "Tender for purchase of unserviceable/ damaged car batteries" and should be sent to the Secretary & Curator, Victoria Memorial Hall, before 12:00 Noon on or before 25.08.2022

The tenders will be opened on the same day at 1:00 PM in the chamber of the Accounts Officer. Tenderers or their representatives may remain present at the time of opening of tender, if they so desire.

The tender should be accompanied by an Earnest Money deposit of Rs. 1,000/- (One thousand) only in the form of a Bank draft in the favour of "Victoria Memorial Hall" payable at Kolkata. Please note that tender without the EMD will be rejected outright. Reserved price is Rs. 12,000/- (Twelve Thousand) only.

The rate should be quoted both in words and figures and be exclusive of all taxes, duties & charges, if any, which, if there be any are to be paid by purchaser from his / their own resources and VMH will not be responsible in any way. The successful bidder will have to deposit the bid amount in full by cash/ DD in favour of "Victoria Memorial Hall" payable at Kolkata within 02 working days on receipt of the letter of award. The unserviceable/ damaged car batteries will have to be removed from the VM campus by the successful bidder at their own cost within 02 days. Any delay in taking delivery of materials beyond the specified period may attract ground rent as per general terms or may lead to termination of contract. The Earnest Money shall be forfeited if the successful bidder withdraws from the offer or does not deposit the bid amount within stipulated period. In case of unsuccessful tenderer/s, the EMD will be refunded at the earliest and latest on or before the 30th day after the award.
