### Tender Notice

Victoria Memorial, 1 Queen's Way, Kolkata 700071 (2223 0953) invites tender from the reputed/experienced contractors for **Removal of Garbage/garden refuges from Victoria Memorial Compound** lying in the VM campus on regular daily basis and per truck basis at the nominated place by KMC. The tender in sealed cover should be superscribed with "Tender for **Removal of Garbage from Victoria Memorial Compound**" must be sent to the Secretary & Curator, Victoria Memorial Hall within 02 p.m. on 28.03.2024. Tenderers are to submit papers about their work experience, Pan Card, GST certificate, Trade Licence, 3 years IT returns etc (all photo copies) alongwith tenders.

The tenders will be opened on the same day at 2.30 p.m. in the chamber of the Accounts officer. Tenderers/their representatives may remain present at the time of opening of tender if they so desire.

The tender should be accompanied by an EMD of Rs.5,000.00 (Rupees five thousand only) in the form of an a/c payee Demand Draft drawn in favour of "Victoria Memorial Hall" payable at Kolkata. However the tenderers who are exempted from furnishing EMD as per GOI orders need not furnish EMD, subject to submission of necessary supporting papers. The Successful bidder will have to deposit performance security @ 5% of the estimated value of the contract, which should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the agency.

Liquidated damages for non-completion of work in time:- One percent per week of the total cost of the work awarded subject to a maximum of 10% of gross value of work done or cost of the work awarded whichever is greater. In the event of the successful tender's inability to complete the work within schedule time, VMH shall have right to terminate the contract.

The rate should be quoted for per TATA 407 and TATA dumper (Big Size) inclusive all charges and taxes. The rate should be quoted both in words and figures. The rate quoted will be valid for 12 months. The successful tenderer will be required to complete the job within 09 a.m everyday. The work should be done under the supervision of the Security Officer. Tenderers may inspect the site on any working day, during working hours before submission of tenders.

VMH reserves the right of rejection of any or all tenders without assigning any reason.
